- Terms and Conditions: SBK Salary Switch Campaign:
- Eligibility: To participate in the SBK Salary Switch Campaign (the "Campaign"), you must be A salaried customer of Stanbic Bank Kenya Limited ("the Bank" or "SBK") with a minimum monthly gross salary of KES 50,000 (Kenya Shillings Fifty Thousand). Participants can be new to the Bank or existing customers whose salary was until the campaign period not channelled through SBK.
